# NOTICE TO CONSUMERS, GENERAL PUBLIC, INTERESTED/AFFECTED PERSONS AND PARTIES NOTICE OF PUBLIC HEARING

## APPLICATION BY PAK GAS DISTRIBUTION COMPANY PRIVATE LIMITED FOR GRANT OF LICENCE FOR SALE OF NATURAL GAS

Pak Gas Distribution Company (Pvt.) Limited, Karachi (PGDC) (applicant) has applied under Rule 4 of the Natural Gas (Licensing) Rules, 2002 for the grant of licence to carry out the regulated activity of the sale of Natural Gas to the end consumers, predominantly CNG stations.

The applicant has informed that they shall purchase LNG from PSO/LNG suppliers. LNG will be re-gasified through execution of an agreement with terminal operator. RLNG i.e. Natural Gas will be injected into the existing pipeline infrastructure of the transporter (SSGCL), on the basis of OGRA Natural Gas (Regulated Third Party Access) Rules, 2012. The applicant shall provide the list of its customer CNG stations to SSCGL for delivery in the same manner and pattern being practiced presently and there will be no modification required at CNG stations.

All persons and parties who are likely to be affected by the grant of licence are hereby notified to file objections, written statements or intervention request addressed to Registrar OGRA, describing the manner in which such persons shall be affected. The application shall be filed alongwith fee of Rs.500/-(bank draft) and affidavit verifying the contents of communication, within 15 days of publication of this notice with a copy to the applicant. Copies of the documents can be obtained on payment of prescribed charges of Rs.2/- per page from the office of the Registrar.
