PUBLIC NOTICE

PETITION FILED BY SUI NORTHERN GAS PIPELINES LIMITED FOR DETERMINATION OF ITS ESTIMATED REVENUE REQUIREMENT/PRESCRIBED PRICES FOR F.Y. 2019-20

Sui Northern Gas Pipelines Limited (the Petitioner) filed a petition before the Authority under Section 8 (1) of the Oil and Gas Regulatory Authority Ordinance, 2002, read with Rule 4 (2) of the Natural Gas Tariff Rules, 2002, on March 64, 2019 for Determination of its Estimated Revenue Requirements /Prescribed Prices for FY 2019-20 with the revised petition on 19 March, 2019 and requested the Authority that an increase of Rs. 722.51 per MMBTU in its normal business of natural gas w.e.f. July 01, 2019.

The breakup of projected prescribed price in respect of natural gas is provided below.

Besides above, the petitioner has estimated RLNG cost of supply at Rs. 111.32/MMBTU, Rs. 80.84 per MMBTU under the head 'diversion of RLNG to domestic consumer' and Rs. 6086.12/MMBTU on account of LPG business.

In view of above petition, OGRA invites all consumers, interveners, general public and interested / affected persons and parties to furnish their comments / interventions / views, if any, on the petition filed by the petitioner, within 14 days from the date of publication of this notice. The intervention request be addressed to the Registrar, OGRA, must contain the name and address of the intervener and be accompanied by an affidavit verifying the contents of the intervention and intervention fee of Rs. 500/- (demand draft in favour of Oil & Gas Regulatory Authority, payable at Islamabad). In case of a person representing any organization/agency/body, he must file an authority letter of the same.
