The Oil and Gas Regulatory Authority (OGRA) invites sealed bids/proposals, for Pre-qualification of Firms for supply of Computers, Laptops, Printers, MS Softwares & its Allied Accessories under Tender Enquiry No.09/2019, **for a period of two years** as per **Annex-I**.

General Terms and Conditions:

- 1) The firm should be registered with Income Tax, Sales Tax Departments and SECP (Registration Numbers should be clearly mentioned and valid documentary evidence should be attached).
- 2) The firm should have a minimum of five (05) years relevant experience of similar assignments and should have proper setup and office at Islamabad/Rawalpindi.
- The pre-qualified firms would be required to submit Security Deposit in the shape of **Call Deposit** of Rs.50,000/- (Rupees fifty thousand only) payable at Islamabad/Rawalpindi, in favour of OGRA and in case of failure, the pre-qualification of the firm will be treated as cancelled. The security will be released to the firms within 30 days after expiry of the period of Pre-qualification. Cash/Cheque will not be accepted.
- As and when a purchase order is placed to the firm, it will be required to deposit a "Performance Bond" equivalent to 5% of the total value of the supply/purchase order in shape of **Call Deposit** payable at Islamabad. In case the firm/supplier fails to deposit performance bond within one week of the receipt of supply/purchase order, the same shall be treated as cancelled and the security deposit shall be forfeited.
- 5) Payments of the bills will be subject to the deduction of government taxes/levies.
- 6) Sealed bids/proposals are required to be delivered at OGRA office located at Plot No. 54-B, Fazal-ul-Haq Road, Blue Area, Islamabad latest by August 27, 2019 on or before 11:00 a.m. The Bid Opening Committee of OGRA shall open the Technical/Pre-qualification proposals (Annex-I) in the first instance at 11:30 a.m. on the same date i.e. August 27, 2019 in the presence of bidders or their authorized representatives who opt to be participated. Subsequently, Technical/Pre-qualification Proposals will be evaluated by OGRA Bid Evaluation Committee as per criteria given at Annex-II.
- 7) OGRA reserves the right to extend the opening date of the bids, cancel/reject any or all proposals as per PPRA Rules.
- 8) Only one authorized representative per bidder shall be allowed to attend the opening of bids.
- 9) An original and latest undertaking/affidavit be attached on judicial paper that the firm has not been blacklisted by any Govt, Semi Govt, Autonomous Bodies or any State owned organization.
