




** (i) If application is complete in all respect, maximum "two working weeks" time is required for getting the documents verified from Banks/SECP etc.


(ii) In case of deficiencies, further time period of maximum "two working weeks" is provided to facilitate the applicant, so that deficiencies can be removed easily and accurately. If the applicant is able to rectify shortcoming and submission of the same before "two weeks" the case is processed at the earliest for grant of licence, without waiting for completion of maximum time period.




Federal Government imposed ban on grant of new CNG License since February 2008.

Construction License procedure for LPG Production/ Extraction, LPG Air Mix, LPG Storage and Filling and LPG Auto Refueling Facilities





Marketing Licence Procedure for LPG Production/ Extraction, LPG Air Mix, LPG Storage and Filling and LPG Auto Refueling Facilities



Provisional Licence Procedure for LNG Facilities





Construction Licence Procedure for LNG Facilities


