General Terms & Conditions:

- The bidder should submit a single package containing two separate sealed envelopes. One envelope should contain the Pre-qualification/Technical Proposal (Annex-I) and the other envelope should contain the Financial Proposal (Annex-II), both showing the Tender Enquiry No. 02 of 2021 and marked as "PRE-QUALIFICATION/TECHNICAL PROPOSAL" and "FINANCIAL PROPOSAL" respectively.
- 2) The firm should be registered with Income Tax, Sales Tax and SECP (Registration Numbers should be clearly mentioned and valid documentary evidence be attached).
- 3) The firm should have a minimum of five (05) years experience in supply & installation of items being procured and should have a proper office at Islamabad/Rawalpindi and be Authorized Dealer (documentary evidence be attached)
- 4) The bidder shall be required to deposit bid security (Earnest money) equal to 3% of total bid value in shape of <u>Call Deposit</u> in favor of OGRA, payable at Islamabad.
- 5) Sealed bids/proposals are required to be delivered at OGRA's office Plot No. 54-B Fazal-UI Haq Road, Blue Area, Islamabad on or before May 10, 2021 by 11:00 a.m. The Bid Opening Committee of OGRA will open the Pre- qualification/

Technical proposals **(Annex-I)** in the first instance on the same date i.e. May 10, 2021 at 11:30 a.m. in the presence of the bidders or their authorized representatives, who may like to be present. Subsequently, technical/prequalification proposals will be evaluated by OGRA's Bid Evaluation Committee as per evaluation/assessment criteria given at **Annex-III.**

- 6) Bids which are not complying with terms and conditions at serial No. 1 to 4 and the specifications mentioned above, shall be declared as Non-Responsive and their financial proposals will be returned un-opened.
- 7) The Bid Opening Committee of OGRA will open the financial proposals (Annex-II) of the bidders whose pre-qualification/technical proposals are accepted, on a date and time to be communicated to them in advance, in the presence of the bidders or their authorized representatives, who may like to be present.
- 8) Only one authorized representative per bidder will be allowed to attend the opening process of the bids.
- 9) The bid validity period will be three (03) months, starting from the last date of bid submission and any escalation in dollar against Pak Rupees shall not be applicable as well as any increase in price within validity period of three months, shall be borne by the bidder. No such claim will be entertained.
- 10) The successful bidder will be required to deposit a "Performance Bond" equivalent to 5% of the total bid value, through <u>Call Deposit</u> in favor of OGRA payable at Islamabad. If the bidder fails to deposit performance bond within one week of the receipt of the letter of acceptance, the same shall be treated as cancelled and the earnest money shall be forfeited.
- 11) 3% Earnest Money if not adjusted in the 5% performance bond, will be released to the successful bidder after deposit of 5% performance bond.
- 12) The supplier will be bound to deliver and install the equipment in operational condition of the approved quality at OGRA office situated at 54-B, Fazlul Haq Road, Blue Area, Islamabad.
- Delivery of eight (08) Photocopier Machines at OGRA,s Head Office should be made within 30 days from the date of letter of acceptance otherwise OGRA reserves the right to cancel the order.
- 14) The proposals should not have any over-writings or cutting. Bids with any of the aforementioned deficiencies may not be considered.
- 15) The purchase order will be awarded to the technically prequalified/lowest evaluated bidder with standard quality.
- Payment of the bills will be subject to the deduction of mandatory government taxes/Levies and subject to satisfactory supply/installation of Photocopier Machines.
- 17) 3% earnest money of the un-successful bidders shall be released within two weeks. However, 5% performance bond of successful bidder shall be released within 30 days after successful completion of one year warranty period.
- 18) Original and latest undertaking/affidavit on judicial paper that the firm has not been blacklisted by any Government/Semi Government, Autonomous or any State Owned Organization.
- 19) All photocopies/certificates/documents submitted with tender documents should be <u>verified/stamped</u>.
- 20) OGRA reserves the right to cancel/reject any or all bids/proposals at any time prior to the acceptance of the bids/proposals as per PPRA Rules, 2004.
