The Oil and Gas Regulatory Authority (OGRA) hereby invites sealed bids/proposals from well-reputed firms/ suppliers registered with Income Tax & Sales Tax departments stationed at Karachi, having minimum five (05) years relevant experience for carrying out renovation & refurbishment works and supply of furniture & misc. other items etc. under Tender Enquiry No. 03/2021.

General Terms & Conditions:

- 1) The bidder should submit a single package containing two separate sealed envelopes. One envelope should contain the Pre-qualification/Technical Proposal (**Annex-I**) and the other envelope should contain the Financial Proposal(**Annex-II**), both showing the Tender Enquiry No. 03 of 2021 and marked as “**PRE-QUALIFICATION/TECHNICALPROPOSAL**” and “**FINANCIALPROPOSAL**” respectively.
- 2) The firm should be registered with Income Tax and Sales Tax Departments (Registration Numbers should be clearly mentioned and valid documentary evidence be attached).
- 3) The firm should have a minimum of five (05) years’ experience in carrying out renovation& refurbishment works / repair works and supply of furniture and other misc. items and should have a proper office at Karachi.
- 4) The bidder shall be required to deposit Bid Security (Earnest Money) equal to 3% of total bid value in shape of **Call Deposit** in favor of OGRA, payable at Islamabad.
- 5) Original and latest Undertaking/ Affidavit on judicial paper that the firm has not been blacklisted by any Government/Semi Government, Autonomous or any State Owned Organization.
- 6) Bids which are not complying with terms & conditions at serial Nos. 1-5, shall be declared as Non-Responsive and their financial proposals will be returned un-opened.
- 7) Sealed bids/proposals are required to be delivered at OGRA’s office Plot No. 54-B, Fazal-UI-Haq Road, Blue Area, Islamabad on or before June 4, 2021 by 11:00 a.m.
- 8) The Bid Opening Committee of OGRA will open the Pre- qualification/ Technical proposals (**Annex-I**) in the first instance on the same date i.e. June 4, 2021 at 11:30 a.m. in the presence of the bidders or their authorized representatives, who may like to be present. The technical /pre-qualification proposals will be evaluated by OGRA’s Bid Evaluation Committee as per evaluation/assessment criteria given at **Annex-III**.
- 9) The Bid Opening Committee of OGRA will open the financial proposals (**Annex-II**) of the bidders whose pre-qualification/technical proposals are accepted, on a date and time to be communicated to them in advance, in the presence of the bidders or their authorized representatives, who may like to be present.

- 10) Only one authorized representative per bidder will be allowed to attend the opening process of the bids.
- 11) Interested firms may visit the OGRA Regional Office located at H. No. D-2, Dattari Villas, Bath Island, Clifton, Karachi at any time during working days/hours (Monday to Friday 9:00 a.m. to 4:00 p.m.) for any clarification/ inspection of the building to see required furniture items/samples etc. If necessary, few furniture items can be seen visually from Head Office Islamabad. Mr. Ejaz Ahmad Gohar, JED (Admn), Head Office, Islamabad and Mr. Khalil Ahmed Sheikh, JED (Complaints) at Regional Office, Karachi has been designated for coordination purpose. - 12) The bid validity period will be three (03) months, starting from the last date of bid submission and any escalation in dollar against Pak Rupees as well as any increase in price shall not be applicable and if so, shall be borne by the bidder. No such claim will be entertained by OGRA.
- 13) The successful bidder will be required to deposit a “Performance Bond” equivalent to 5%(including 3% initial) of the total bid value, through **Call Deposit** in favor of OGRA payable at Islamabad. If the bidder fails to deposit performance bond within one week of the receipt of the letter of acceptance, the same shall be treated as cancelled and the earnest money/ all deposit shall be forfeited.
- 14) The bidder/firm will be bound to undertake necessary repair/renovation works and supply of the requisite furniture items etc. in a very good condition and as per the approved quantity & quality and per other requirements / specifications given in the tender documents at Regional Office, Karachi, situated at House No. D-2, Dattari Villas, Bath Island, Clifton, Karachi.
- 15) The time period for compellation of works is two (02) weeks, starting from the date of Acceptance Letter from successful bidder. In case of failing, the Authority reserves the right to cancel the order.
- 16) The proposals should not have any over-writings or cutting. Bids with any of the aforementioned deficiencies may not be considered.
- 17) The Work/ Purchase order will be awarded to the technically prequalified/lowest evaluated bidder on **lump sum Rate basis**(aggregate of Total Financial Proposal as per the attached Summary – Financial Bid).
- 18) Payment of the bills will be subject to the deduction of mandatory government taxes/Levies and subject to satisfactory supply/installation of items/ completion of tasks/ works.
- 19) 3% Earnest Money of the un-successful bidders shall be released within two weeks.However,5% performance bond of successful bidder shall be released within 30 days after successful completion of all works.
- 20) In case, the last date of submission of bids falls on closed official days/ holidays, the date for submission & opening of the bids shall be the next working day.
